The Somerston Multi Asset Fund (US0 class) returned -0.3% in the month and +5.9% for the last three months.

The MSCI World Equity Index fell by -0.3% during the month and a composite of UK, German and US Government bonds rose by +2.5% in the month. Our Composite Benchmark Index increased by +0.6% in the month and by +4.0% over the last three months.

The Net Asset Value of the Fund is USD 36,652,093 at the end of the month.
