

# SOMERSTON MULTI ASSET FUND Monthly Fact Sheet as at 30 April 2020

The Somerston Multi Asset Fund (US0 class) rose by +6.9% in the month and fell by -7.9% over the last three months.

The MSCI World Equity Index rose by +10.5% during the month and a composite of UK, German and US Government bonds rose by +0.7% in the month. Our Composite Benchmark Index gained +7.6% in the month and fell by -6.8% over the last three months.

The Net Asset Value of the Fund was USD 33,506,389 at the end of the month.
