

SOMERSTON MULTI ASSET FUND Monthly Fact Sheet as at 30 October 2020

The Somerston Multi Asset Fund (USO class) fell by -1.0% in the month and fell by -0.2% over the last three months.

The MSCI World Equity Index fell by -3.1% during the month and a composite of UK, German and US Government bonds fell by -0.2% in the month. Our Composite Benchmark Index fell by -2.2% in the month and fell -0.1% over the last three months.

The Net Asset Value of the Fund was \$37,950,059 at the end of the month.
