

# SOMERSTON MULTI ASSET FUND Monthly Fact Sheet as at 30 November 2020

The Somerston Multi Asset Fund (US0 class) rose by +5.2% in the month and rose by +1.8% over the last three months.

The MSCI World Equity Index rose by +12.0% during the month and a composite of UK, German and US Government bonds fell by -0.2% in the month. Our Composite Benchmark Index rose by +8.3% in the month and rose by+ 4.0% over the last three months.

The Net Asset Value of the Fund was \$40,606,735 at the end of the month.
